

E/M University Online Compliance Programs

There are two options for setting up your E/M Compliance Web Portal

E/M Compliance Web Portal without monitoring and verification: We set up your E/M Compliance Web Portal but we *do not* provide any built-in monitoring and verification. (To verify your compliance education, you can have your providers print out their CME certificates as they complete each learning module.)

E/M Compliance Web Portal with monitoring and verification: We set up your E/M Compliance Web Portal and provide built-in real-time monitoring so you can see exactly when each provider completes each online learning module. This allows your compliance team to confirm that corrective educational activities were completed.

Price Structure

There are two elements to the price structure for an E/M Compliance Web Portal

1. Set-up fee: Designing, maintaining and hosting your Web Portal (One-time fee)
2. Yearly access fee: Unlimited access to all online learning modules and CME

Set-up fee: This is a one-time fee for designing, hosting and maintaining your E/M Compliance Web Portal. You do not have to have a website of your own. We build your web page and host it on our secure server. Each web page is pre-loaded with all of our online learning modules and can be customized with your logo. Once your E/M Compliance Web Portal is up and running, it provides a centralized location where all your providers can go to receive targeted E/M coding and documentation education.

Yearly access fee: This is a recurring annual fee for unlimited access to all online E/M coding modules for all providers for one year. This fee includes all applicable CME credit.

- ◆ One-time set-up fee: \$1,000
- ◆ Yearly access fees:
 - Up to 10 providers: \$500/yr
 - Up to 20 providers: \$750/yr
 - Up to 30 providers: \$1,000/yr
 - Up to 50 providers: \$1,500/yr

Prices for E/M Compliance Web Page with monitoring and verification

- ◆ One-time set-up fee: \$2,000
- ◆ Yearly access fees:
 - Up to 10 providers: \$750/yr
 - Up to 20 providers: \$1125/yr
 - Up to 30 providers: \$1,500/yr
 - Up to 50 providers: \$2,000/yr

Example: Suppose you want an estimate for setting up an E/M Compliance Web Portal for your multi-specialty group which includes 18 physicians.

E/M Compliance Web Portal (without monitoring and verification)

1. Set-up fee: \$1,000
2. Yearly access fee: \$750/year

Total cost for first year: \$1,750

Yearly cost after the first year: \$750

E/M Compliance Web Portal with monitoring and verification

1. Set-up fee: \$2,000
2. Yearly access fee: \$1,125/year

Total cost for first year: \$3,125

Yearly cost after the first year: \$1,125
